Public Officer denoted that only 30% of the member clubs voted and/or submitted attendance/apology for the 2022 AGM. Clubs are reminded that voting is compulsory under the constitution and is the chance for clubs to have their input into the direction of the sport.

### 9. General Business:

## Norwood:

- Provided feedback and commenced discussion on the implementation of the Sport Integrity Australia training requirements for officiating and the necessity for this.
- Noting the time consuming and technical issues with education platform SwimmingSA has removed this requirement from officials for the time being.
- Further discussion to be had with clubs on the implementation and evidence of safe sport environments within swimming to ensure legislative and policy requirements and outcomes are met.
- Discussion on Swim Central options for helping provide club administrators with a way to choose who they
  accept as members or not and what requirements can be tied to membership such as WWCC to ensure
  ease of implementation of club/state policy.
