

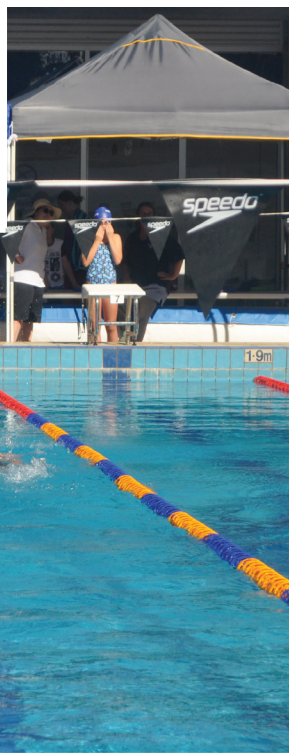

Chairman and Chief Executive Officer's Report

Staff have been able to keep club administrators abreast of the latest developments from Health Authorities and from sports governing bodies by promulgation of information in a timely manner and we thank all Club Presidents, Coaches and their teams for sticking with us throughout the year and doing your best for the sport.

As we are all aware the pandemic has impacted the road to the Tokyo Olympics, Paralympics and other international competitions. National titles had to be abandoned and we missed seeing SA Athletes thrive in the national arena but as we review 2020 and look forward to 2021 the soon to be released SA Strategic Plan is about the future. 2020-21 Australian Championships will be upon us before we know it soon to be followed by Paris (2024), Los Angeles (2028) and our Olympians for 2032 are presently in the formative years of their swimming careers and goals. By embracing this plan and working together, the future is all but ensured.

On the national front, the situation (like our own) is uncertain but Swimming Australia is working toward a return to normality as soon as is practicable and within health guidelines. Both the national body and Swimming SA have taken a financial hit and staff in both organisations have had to make personal sacrifices, as have many people around the nation.

Participation is our primary goal. We have long believed that the true champions will emerge as athletes commit and dedicate themselves to the aspirations and goals they set in conjunction with their coaches and support "crews".

As previously said, we are all here for the betterment of the sport and to provide an avenue for committed and dedicated athletes to meet the challenges and objectives they have set themselves and give of their best. It is timely for all to update themselves on the SwimmingSA Values and Behaviours as they will guide us all to achieve best practice in the conduct and governance in our sport.

There have been changes within the Swimming Australia hierarchy. John Bertrand AM has completed his term as President and Kieren Perkins has been elected to that role. Given the impact of the COVID pandemic, CEO, Leigh Russell has also decided to relinquish her role and a successor will be identified in due course. On behalf of Swimming SA, I thank Mr. Bertrand and Ms. Russell for their commitment, dedication, and leadership during their term of office.

Participation is our primary goal. We have long believed that the true champions will emerge as athletes commit and dedicate themselves to the aspirations and goals they set in conjunction with their coaches and support “crews”.

Our membership numbers remained relatively stable with a marginal decrease in overall numbers. The number of affiliated clubs dropped slightly with 4 clubs being unable to successfully re-affiliate for the 2020/21 season. The addition of COVID-19 plans, new coaching requirements and changing community landscapes made the affiliation process challenging, we would like to take this opportunity to acknowledge the hard work of our club committees and administrators, who have been involved and made it happen.

The ‘Swim Central’ technology platform continues to develop and Swimming Australia have created our committee to drive and oversight the project to completion. Again, SwimmingSA have been leaders in this respect.

Sincere thanks goes to our sponsors, partners, athletes, coaches, officials, volunteers, and sub-committee representatives for their ongoing support and commitment. Together with athlete parents and carers, you are an important and integral part of the swimming community.

Our thanks also go to the Office of Recreation. Sport and Racing for their input and guidance, particularly during these difficult and uncertain times. The management and staff at the SA Aquatic and Leisure Centre have also stood with us during this awkward period and that support is appreciated as is the advocacy of Sport SA on behalf of all sporting organisations in our great State.

We often reflect on the national emblems that are depicted on our coat of arms; the Kangaroo and the Emu as neither can take a backward step. Let us take a leaf from this book and move forward together to the success we all strive for.

Finally, we encourage all athletes to commit to your goals and give of you best. We wish you every success for this season and beyond.

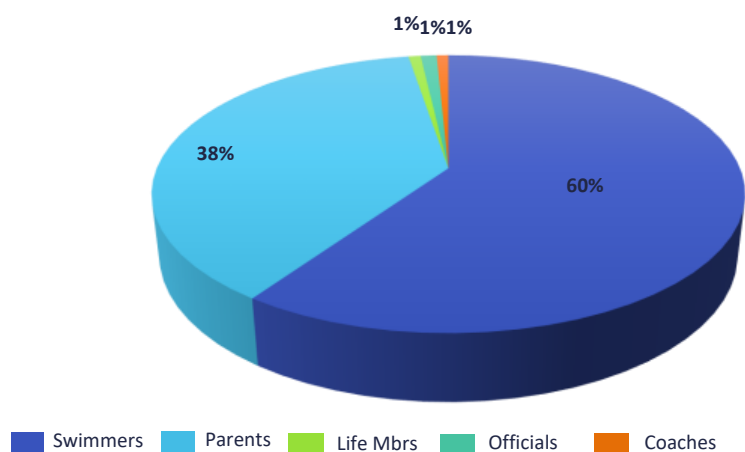

Objectives

The Vision of SwimmingSA Incorporated is to be recognised as one of the Top 5 Sports in SA. The Mission is to provide a structure, which creates, and supports increased participation, enjoyment and athletic achievement for South Australians within the sport of swimming.

Strategy for achieving the objectives

During the year through our three Strategic Pillars of Partnerships, Participation and Performance, SwimmingSA Incorporated has implemented key strategies such as those noted below to achieve our objectives:

- Increased the number of people involved in coaching and officiating through a range of inclusive opportunities and programs that promote, encourage and up skill these stakeholders;
- Encouraged best practice and innovative club management by providing leadership, support, resources, education & training and business tools that promote improved efficiencies, effectiveness and outcomes;
- Developed an integrated competition pathway and enhanced national and international profile through securing major swimming competitions to South Australia;
- Optimised funding opportunities through government, Swimming Australia and sporting programs and grants; and
- Enhanced relationships with State & local Government, State political bodies, Events SA, SASI, ASCTA, SAL other aquatic sports and delivery agents to increase the profile of swimming.

Principal activities

During the financial year the principal continuing activities of the incorporated association were to:

- Promote and encourage participation in swimming activities;
- Conduct sustainability activities with regions and clubs;
- Provide high performance development and competition for athletes;
- Foster partnerships with other SA Aquatic Sports;
- Administer the sport for the benefit of all participants; and
- Implementation of a best practice Safe Sport Framework.

There was no significant change in the nature of the activity of the incorporated association during the year.

Performance measures

The incorporated association measures its performance in the amount of funds put back into activities of the sport. Such activities are measured on participation numbers, athletic performance and governance sustainability. The key performance measures are funds raised compared to developmental expenses, total cost per activity delivered to the community and the total number of activities conducted.

Review of operations

The incorporated association for 2020 financial year recorded a surplus of \$166,336 (2019: deficit \$39,108).

Matters subsequent to the end of the financial year

No matter or circumstance has arisen since 30 June 2020 that has significantly affected, or may significantly affect:

- the incorporated association's operations in future financial years, or
- the results of those operations in future financial years, or
- the incorporated association's state of affairs in future financial years.

Likely developments and expected results of operations

The incorporated association expects to maintain the present status and level of operations and hence there are no likely developments in the association's operations.

Environmental regulation

The incorporated association is not affected by any significant environmental regulation in respect of its operations.

Association Public Officer

The incorporated association's Public Officer is Michelle Doyle.

Subsequent Events

As a result of the evolving nature of the COVID-19 pandemic, its economic impact and the rapidly evolving government restrictions to contain it, the incorporated association is not in a position to reasonably estimate any further impact to the future financial performance and the financial position of the incorporated association in any changed circumstances that may arise.

Auditor

Manos Partners is the appointed auditor.

Note 1. Significant accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

The incorporated association has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') that are mandatory for the current reporting period.

The adoption of these Accounting Standards and Interpretations did not have any significant impact on the financial performance or position of the incorporated association.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

The following Accounting Standards and Interpretations are most relevant to the incorporated association:

AASB 16 Leases

The incorporated association has adopted AASB 16 from 1 July 2019. The standard replaces AASB 117 'Leases' and for lessees eliminates the classifications of operating leases and finance leases. Except for short-term leases and leases of low-value assets, right-of-use assets and corresponding lease liabilities are recognised in the statement of financial position. Straight-line operating lease expense recognition is replaced with a depreciation charge for the right-of-use assets (included in operating costs) and an interest expense on the recognised lease liabilities (included in finance costs). In the earlier periods of the lease, the expenses associated with the lease under AASB 16 will be higher when compared to lease expenses under AASB 117. However, EBITDA (Earnings Before Interest, Tax, Depreciation and Amortisation) results improve as the operating expense is now replaced by interest expense and depreciation in profit or loss. For classification within the statement of cash flows, the interest portion is disclosed in operating activities and the principal portion of the lease payments are separately disclosed in financing activities.

Basis of preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board ('AASB'), and the South Australian legislation the Associations Incorporation Act 1985 and associated regulations, as appropriate for not-for-profit oriented entities.

Historical cost convention

The financial statements have been prepared under the historical cost convention.

Critical accounting estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the incorporated association's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed in note 2.

Revenue recognition

Revenue is recognised when it is probable that the economic benefit will flow to the incorporated association and the revenue can be reliably measured. Revenue is measured at the fair value of the consideration received or receivable.

Sales revenue

Event and membership fees are recognised when received or receivable.

Grants

Grants are recognised at their fair value where there is a reasonable assurance that the grant will be received and all attached conditions will be complied with.

Note 1. Significant accounting policies (continued)

Interest

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

Income tax

No provision for income tax has been raised as the incorporated association is exempt from income tax under Div 56 of the Income Tax Assessment Act 1997.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Trade and other receivables

Trade and other receivables are recognised at amortised cost, less any provision for impairment.

Property, plant and equipment

Plant and equipment is stated at historical cost less accumulated depreciation and impairment. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Depreciation is calculated on a straight-line basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the incorporated association. Gains and losses between the carrying amount and the disposal proceeds are taken to profit or loss.

Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

Note 1. Significant accounting policies (continued)

Right-of-use assets

A right-of-use asset is recognised at the commencement date of a lease. The right-of-use asset is measured at cost, which comprises the initial amount of the lease liability, adjusted for, as applicable, any lease payments made at or before the commencement date net of any lease incentives received, any initial direct costs incurred, and, except where included in the cost of inventories, an estimate of costs expected to be incurred for dismantling and removing the underlying asset, and restoring the site or asset.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the incorporated association expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life. Right-of use assets are subject to impairment or adjusted for any remeasurement of lease liabilities.

The incorporated association has elected not to recognise a right-of-use asset and corresponding lease liability for short-term leases with terms of 12 months or less and leases of low-value assets. Lease payments on these assets are expensed to profit or loss as incurred.

Trade and other payables

These amounts represent liabilities for goods and services provided to the incorporated association prior to the end of the financial year and which are unpaid. Due to their short-term nature they are measured at amortised cost and are not discounted. The amounts are unsecured and are usually paid within 30 days of recognition.

Lease liabilities

As indicated in note 1, the incorporated association adopted AASB 16 Leases retrospectively from 1 July 2019 but has not restated comparatives for the 2019 reporting period as permitted under the specific transition provision in the standard. The reclassification and the adjustments arising from the new leasing rules are therefore recognised in the opening balance sheet on 1 July 2019.

The incorporated association leases its office and various office equipment. Lease contracts are typically made for fixed periods up to five years., but may have extension options.

Lease terms are negotiated on an individual basis and contain a wide range of different terms and conditions. The lease agreements do not impose any covenants other than the security interests in the leased assets that are held by the lessor. Leased assets are not used as security for borrowing purposes.

Until the 2019 financial year, leases of property, plant and equipment were classified as either finance leases or operating leases. From 1 July 2019, leases are recognised as a right-of-use asset and a corresponding liability at the date at which the leased asset is available for use by the incorporated association.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives available
- variance lease payments that are based on an index or a rate, initially measured using the index or rate as at the commencement date
- payments of penalties for terminating the lease, if the lease terms reflects the incorporated association exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability

Employee benefits

Short-term employee benefits

Liabilities for wages and salaries, including non-monetary benefits, annual leave and long service leave expected to be settled wholly within 12 months of the reporting date are measured at the amounts expected to be paid when the liabilities are settled.

Note 1. Significant accounting policies (continued)

Other long-term employee benefits

The liability for annual leave and long service leave not expected to be settled within 12 months of the reporting date are measured at the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash outflows.

Fair value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

Goods and Services Tax ('GST') and other similar taxes

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the tax authority is included in other receivables or other payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to the tax authority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the amount of GST recoverable from, or payable to, the tax authority.

Note 2. Critical accounting judgements, estimates and assumptions

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Employee benefits provision

As discussed in note 1, the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

COMPETITIONS COMMITTEE REPORT 2019 – 2020

The outbreak of the worldwide pandemic of COVID-19 has affected all aspects of life, and this included swimming. Our Winter competition significantly curtailed in line with the majority of sports across the nation and the world. Nationally, the Australian Swimming Championships and Australian Age Swimming Championships were both cancelled, much to the disappointment of the many South Australian swimmers that had qualified for these events.

Our Long Course Championships were again very successful with almost 1000 swimmers entering the meet. Finals sessions were again streamed live presenting a very professional meet to the world thanks to a change in our broadcast provider. The meet was reported on by the international swimming media as there was a strong representation of potential Olympians competing at our meet in preparation for an Olympic year.

This year's Country Championships were held in Murray Bridge, and it was once again a very successful meet. For the first time, qualifying times were enforced rather than standard time. However, this had little effect on the number of entries.

Our Open Water State Championships returned to its preferred location of the West Lakes Rowing Course on a more traditional date in early December with good representation from clubs across the state. Disappointingly there were no entries from any visitors from interstate this year.

Last year saw the introduction of the SA Districts Championships which was held in March at the Valleys Lifestyle Centre in Clare. An initiative of the Country Committee, this meet enabled our country swimmers to compete in a meet representing their district rather than their clubs. However, this year entries were at an unacceptable low level, and the difficult decision was made to cancel this event for this year and is unlikely to be reinstated in the near future.

The Participation strand mostly consists of the various Club Carnivals run across the state. Carnivals fill multiple roles, with a strong emphasis on participation and social interaction, but increasingly are becoming important adjuncts to the Division 1 meets as another means of setting a qualifying time for our State Championship meets. However, I would like to acknowledge the many clubs that had nominated and planned to run the open carnivals during Winter but were forced to cancel due to COVID-19. These events are key components of a club's fundraising efforts over the course of a year, and I acknowledge the potentially difficult position that these cancellations have caused.

During the year the Events Coordinator and Athlete and Coach Performance Officer convened a meeting with the coaches to canvas their views on our Championship Events. Some of their recommendations coming from this meeting have been adopted for the coming season, and we welcome their input in discussion in the future.

During the coming year the Board will undertake a review of the Competitions Committee in order to determine the best way to manage our competition structure into the future.

Thanks

I would like to commend our CEO Michelle Doyle and her team for the excellent work that they do in the background. I would especially like to mention the enormous achievement in logistics last January where three championship events – SA Open Water Championships, SA Country Championships and SA Long Course Championships – were run in a 3-week period. The logistics to run the Open Water Championships on the first Sunday in January and the Country Championships beginning 4 days later was an achievement of the highest order.

I would like to thank all the members of our committee, Donna Sampson, Shaun Curtis and Anthony Davies who joined us for the first time this year and returning members Michelle Whitaker and Ynez Grimes. Retiring from the committee in 2019, I would like to thank Phil Bowen for his sage advice and many years of experience. The committee was very well supported by Athlete and Coach Performance Officer Cory Bampton for bringing the views of the coaches to the committee, Michelle Doyle for everything that she does, and the staff liaison Sarah-Jane Couche. However, the position of Event Coordinator was made redundant as a result of the COVID-19 crisis and Sarah-Jane left Swimming SA at the end of April. I would like to offer my thanks to her for the amazing work she undertook in her time at Swimming SA and wish her well for the future.

SwimmingSA Development Report 2019-2020

The 2019-2020 season has been a season like no other and has seen our members challenged in a number of ways both in and out of the pool. We have experienced shutdowns in both training activity and pool access as well as restrictions limiting our ability to offer competitions to our members. These restrictions caused the cancellation of almost all development activities that were planned to occur during this season. This landscape meant that the athlete and coach development approach had to be adapted with the clubs and coaches taking on the responsibility of athlete development. This was something they took on without hesitation.

With such strong restrictions rendering the traditional training and competition activities impossible our clubs and coaches adapted and upskilled themselves in a number of new mediums to remain engaged with each other and their training. The majority of SA clubs held regular online training sessions for their members led by their dedicated club coaches. These sessions were a fantastic initiative and were viewed by many members as being a very big influence on the physical and mental wellbeing of our members during the state shutdown.

It was exciting to see the Adelaide Anacondas relay meet come to fruition and we look forward to future opportunities in this space.
